SUPERINTENDENT'S REPORT

Board Recognition

Superintendent, Dr. VanWagoner, extended appreciation to the TCAPS Music Department. Dr. VanWagoner recognized staff and students for being selected to perform as part of the All-State Band, Orchestra Ensembles, and the 6-7-8-9 Honors Choir during the Michigan Music Conference. The Michigan Music Conference was held at the DeVos Performance Hall in Grand Rapids from January 19 through 21.

Dr. VanWagoner extended recognition to Erich Wangeman, Traverse City West Senior High School choral director, who conducted the Michigan School Vocal Music Association (MSVMA) TTBB Honors Choirs on January 21. He was selected by his MSVMA peers to lead the 2023 TTBB Honors Choir.

Wendee Wolf-Scharf was also recognized by Dr. VanWagoner as one of the reasons TCAPS continues to have the most comprehensive and highly respected K-12 Music Curriculum in the state of Michigan. The Michigan Music Conference, the largest and most comprehensive in-service convention for music educators in the Midwest, has had Wendee as a common leader on its operating board since its inception eighteen years ago.

District Highlights

Transportation Update:

Dr. VanWagoner provided an update on transportation services. Reporting that three drivers have recently been hired and that the district isn't aware of any students not making it to or from school because of the route reductions. Administration has extended the current route reduction until spring break.

Enrollment:

Sports:

Dr. VanWagoner presented district sports highlights.

Legislative Update:

Administration has reviewed the newly released School Aid Budget. A tutoring program was added to the budget for the summer and administration will continue to review what that entails. Dr. VanWagoner announced that the district received funding for one School Resource Officer (SRO). The funding for the SRO will begin next school year. Administration will continue to work with local legislators to advocate for additional funding. Dr. VanWagoner stated that it is still early in the budgeting process and he will continue to bring updates to the Board.

Goal Progress Report:

Public Act 48 of 2021, Section 98b requires school districts to present to the Board the accomplishments of established goals for the 2022/2023 school year. Heidi Maltby-Skodack, Director of School Improvement /STEM/CTE, explained the expectation is to track and monitor student growth and achievement from the beginning of the year to the end of the year. Heidi presented the Board with an overview of standardized test data.

a. School Safety Update

Dr. VanWagoner presented the Board with a school safety update. TCAPS received confirmation that they have been awarded one School Resource Officer (SRO). This is a 50% match for three years. Administration will discuss with local law enforcement to determine what best fits the needs of the district when determining placement for the SRO. The funding for this SRO will begin next school year.

Dr. VanWagoner and Patrick McManus, Safety & Security Coordinator, are holding voluntary meetings with each school to review the recent school safety assessment done by Secure Education Consultants (SEC).

Patrick continues to work with local emergency management to review and practice safety plans. TCAPS also continues to work with local law enforcement to further improve school safety.
