District Highlights

MSBOA District II Marching Band Expedition

Transportation Survey/Current Situation

The district sent out a survey to gauge public input as we continue to face bus driver shortages. Dr. VanWagoner shared the survey results with the Board. He also mentioned that two (2) Central High School afternoon bus routes will be delayed on October 11. While the students who are affected wait for a bus to return, there will be supervision provided. TCAPS is hiring school bus drivers. This opportunity provides full paid training, flexible scheduling, excellent benefit packages, sign on bonuses up to \$1,000; hourly rates this year: \$21/hour-\$23.75/hour depending on experience. Dr. VanWagoner shared that the district is not required to provide transportation for general education students, including non-public and parochial schools.

Legislative Update

Dr. VanWagoner indicated he is hoping the new retirement law will be looked at during lame duck to allow retirees to return after 30 days.

Learning Loss Plan (98c fund use)

Dr. VanWagoner provided the Board with an overview of how 98c funds would be used if awarded. They are as follows:

NWEA, state assessments and the number of students reached were used as metrics to determine where funds should be spent.

He indicated that he anticipates a report from the Secure Education Consultants (SEC) later this month. He also shared that the Michigan State Police (MSP) grant for School Resource Officers (SRO) was released today. The grant is due in November and will be awarded in January. The grant is to fund an SRO for three (3) years and is a competitive grant.
