d. Portrait of a Graduate

g. Board Policy

The Board considered approval of the following revised policy:

i. Board Policy 8390: Animals on District Property (REVISED)

Administration discussed with the Board the current update of this policy. Administration encourages the use of therapy animals but considers the safety and liability of a therapy animal to be important as well. Administration informed the Board that the new administrative guidelines include a form that staff members would submit to the curriculum department for approval of an animal on district property. The

information provided in the form submission would be tracked yearly to maintain compliance. There is also an opt-out form that has been created. Administration believes this new process will allow for a safer environment for students and staff.

Dr. VanWagoner discussed with the Board two animals that would not meet the requirements of Board Policy 8390. One dog is located at Central High School and the other dog is at Traverse City High School. These dogs pose a liability to the district because they are unable to meet the requirements of the revised policy. The Board agreed with administration that these two dogs would not need to meet the requirements of Board Policy 8390, confirming that they would be legacied to the revised policy.
