### a. Human Resources

Board President Newman-Bale deferred to the Associate Superintendent of Labor Relations and Legal Services, Coni Taylor, to provide an update on the following items:

# i. Staffing Update

Class sizes and composition are being monitored daily. As of yesterday, all elementary positions are filled. The district currently has the following positions posted: custodial, transportation, food service, special education and overload aides, extended day and more. The Human Resources Department has reviewed 650 applications, held 175 interviews, filled 65 new positions, and transitioned 50 current staff within the district.

### ii. Policy Transition Update

The new policy manual has been ordered from Thrun Law and Ms. Taylor will work with her staff to begin facilitating a review process.

# iii. Professional Development Opportunities

Based on feedback from hourly staff, the district has worked with NorthEd to provide several professional development opportunities in seclusion and restraint, safety, technology and legal information.

# b. Communications Update

Board President Newman-Bale deferred to the Executive Director of Marketing and Communications, Ginger Smith, to provide an update on the following items:

### i. Community Health Expo

This year's Staff Welcome Back had a new format with a focus on Health and Wellness and more direct contact with community partners. Staff and community partners provided positive feedback on the new format.

### ii. Current Advertising

Enrollment initiatives are still underway through commercials and social media presence.

### iii. Back to School SSN initiatives

This year the district launched an intake process for tracking services that are received by TCAPS students. To date for the 2023/24 school year, 50 McKinney-Vento students have been identified. Staff are working to help these students with transportation and other back to school essentials. Ms. Smith thanked Rotary Charities and The Presbyterian Church of Traverse City for backpacks and school supplies. Tomorrow, Friday, September 1 will be the last date for the Sunshine Bus Summer Enrollment Tour.
