4. RECOGNITION

Traverse Bay Sunrise Rotary Club

Dr. VanWagoner and the Board of Education recognized Traverse Bay Sunrise Rotary Club for their mission to increase early literacy and kindergarten readiness in our community with the Born to Read Project. Established in 2011, Born to Read is one of three signature projects of the Traverse Bay Sunrise Rotary Club. Their mission is to increase early literacy and kindergarten readiness in our community.

Working together with partner organizations, Rotary volunteers distribute books and spread the word to parents and caregivers about the importance of reading, singing, and talking with young children every day from birth on.

At Munson Medical Center, they provide a Welcome Baby gift for all new parents with a book for baby, literacy information, and connection to the library and other community resources, reaching 1500 families a year. Through their "Books from Birth" initiative, they've recently partnered with Dolly Parton's Imagination Library GTR to offer all babies from the 5- county region born at Munson the opportunity to receive Imagination Library books every month until their 5th birthday, at no cost to families.

In partnership with TCAPS, Sunrise Rotarians and other volunteers serve as Born to Read Ambassadors reading

with children at Blair Elementary and Traverse Heights Elementary Schools. Also providing age-appropriate books to early childhood programs.

They distribute children's books and literacy information to parents in partnership with Traverse Area District Library and other area libraries, 5toONE, Father Fred's Pantry to Preschool Project, United Way's United We Smile dental program, Northwest Michigan Health Services, the Grand Traverse Health Department's WIC program, Grand Traverse Baby Pantry, NMC Children's Center, and other community organizations. We also maintain 3 Little Libraries in the community.

In the past year, Born to Read volunteers have reached hundreds of families with their Message and distributed 7,000 age-appropriate books to young children in the community.

The Program consists of 12 education leaders from districts across Michigan committed to professional growth. As part of the initiative, fellows participate in concentrated leadership training over one year. As an extension of their study, the Gerstacker Fellows will travel to Finland and Germany in April to meet with educators from various educational institutions to learn about global educational systems and different cultures.

STEM Groundbreaking

Board members, staff, students, and many business leaders were on hand at the District's recent groundbreaking ceremonies to mark the official beginning of construction for the Manufacturing and Innovation Centers being built on the campuses of both West Senior High School and Central High School. The spaces will be used for various academic and co-curricular needs tied to science, technology, engineering, and math as well as robotics and manufacturing. These facility additions are funded through the district's 2018 capital bond.
