Reconfirmation Meeting for **April 2021**

Reconfirm instructional delivery method
TCAPS continues to utilize three platforms for instructional delivery during the month of April under Pandemic Learning. Remote teaching has been utilized for classrooms where either the student(s) and/or teacher have had to quarantine or self-isolate. On April 5th, all preK-5 students participating in face-to-face instruction returned to in-person learning. Students participating in UPNV Live and On-Demand continued within their platforms. However, based on the recommendations from the Governor and Board decision, face-to-face students in grades 6-12 moved to remote learning from April 5th-April 16th. Secondary face-to-face students returned to in-person instruction on April 17th.

Pre-Kindergarten: PK students are enrolled in one of the following learning platforms Face to Face: ECSE (34) & GSRP (26) : 59 students Remote Learning: 6 ECSE
Elementary (Grades K - 5): K-5 students are enrolled in one of the following learning platforms Face-to-face: 3329 UpNorth Virtual Live: 319 UpNorth Virtual On-Demand: 157
Middle School (Grades 6 - 8): 6-8 students are enrolled in one of the following learning platforms Face-to-face: 1696 UpNorth Virtual Live: 188 UpNorth Virtual On-Demand: 109
High School (Grades 9 - 12): 9-12 students are enrolled in one of the following learning platforms Face-to-face: 2816 UpNorth Virtual Live: 141 UpNorth Virtual On-Demand: 207
