Reconfirm instructional delivery method

TCAPS continues to utilize three platforms for instructional delivery during the month of March under Pandemic Learning. Remote teaching has been utilized for classrooms where either the student(s) and/or teacher have had to quarantine or self-isolate. On March 5th, all preK-12 students participating in face-to-face instruction returned to in-person learning. Students participating in UPNV Live and On-Demand continued within their platforms. First semester ended on March 22nd for all students.

High School (Grades 9 - 12): 9-12 students are enrolled in one of the following learning platforms Face-to-face: 2835 UpNorth Virtual Live: 148 UpNorth Virtual On-Demand: 226
