Reconfirmation Meeting for November 2020

Reconfirm instructional delivery method
TCAPS continues to utilize three platforms for instructional delivery during the month of November under Pandemic Learning. Remote teaching has been utilized for classrooms where either the student(s) and/or teacher have had to quarantine or self-isolate. Beginning November 11th, TCAPS secondary schools, grades 6-12, moved to remote instruction due to limitations with staff impacted by COVID-19 quarantine. Per the new Emergency Order 333.253, all students K-12 were moved to remote learning beginning November 18th through December 8th, 2020. Licensed programming, including GSRP, continued face-to-face.

Middle School (Grades 6 - 8): 6-8 students are enrolled in one of the following learning platforms Face-to-face: 1981 UpNorth Virtual Live: 158 UpNorth Virtual On-Demand: 166
High School (Grades 9 - 12): 9-12 students are enrolled in one of the following learning platforms Face-to-face: 3238 UpNorth Virtual Live:115 UpNorth Virtual On-Demand: 237
