TRAVERSE CITY AREA PUBLIC SCHOOLS PUBLIC HEARINGS AND MATERIAL REVIEW REGARDING THE SEX EDUCATION CURRICULUM

Please take notice, that a Sex Education Curriculum Material Review and two Public Hearings for Traverse City Area Public Schools are planned. According to Michigan Law, all school districts must conduct two public hearings on any additions or revisions of the sex education curriculum or materials and have Board of Education approval before implementation.

The additions and revisions of the sex education curriculum included in this material review and public hearings were reviewed and approved by the Sex Education Advisory Board (SEAB) during the 2021-22 school year.
