Reconfirmation Meeting for **SEPTEMBER 2020**

Reconfirm instructional delivery method
TCAPS utilized three platforms for instructional delivery during the month of September under Pandemic Learning. Beginning September 8th, 2020 through September 18th, 2020 all students engaged in fully remote learning. Daily attendance was taken utilizing Google Meet and/or two-way communication for those students enrolled in asynchronous virtual courses. On September 21st, 2020, students enrolled as face-to-face returned to school buildings, while our UpNorth Virtual Live students continued on with their remote learning sessions, and our UpNorth Virtual On-Demand students continued with their asynchronous courses through either Lincoln Learning (K-5) or Edgenuity (6-12). Students were able to change their learning platforms up until September 28th, 2020.

High School (Grades 9 - 12): 9-12 students are enrolled in one of the following learning platforms Face-to-face: 2905 UpNorth Virtual Live: 117 UpNorth Virtual On-Demand: 247
